Upon party reservation – we must collect a \$50 deposit (which will be used towards any property damages and/or participant overage), and the FULL payment of the party. The payment is fully refundable if the event is cancelled at least 48 hours before the scheduled party and COM is notified. Payment will be required in two methods: For the payment of party, you may pay with cash, credit card or check. For the deposit fee, we ask that you pay with a check. If no damages to the COM facility occur and no more than participants than registered are in the water, the \$50 deposit will be returned.

Information and Facility Rules

Please note the facility should be vacated by the end of the scheduled time period. The renter is responsible for and will be charged for the full cost of clean up or repairs for damage to the COM Aquatics Inc. facility and grounds caused by the event participants.

ALCOHOL AND ILLEGAL SUBSTANCES are prohibited in the COM Aquatics Inc. facility and/or parking areas. **DISORDERLY BEHAVIOR WILL NOT BE TOLERATED.** The management reserves the right to terminate activities at any time due to a lack of supervision by the attending adults and/or facility policies have been violated. **THERE WILL BE NO REFUND.**

- No participants are allowed in the facility unless supervised by qualified COM Aquatics Inc. Lifeguards and/or staff.
- Do not arrive early to set up. There may be other parties at the facility. Please show up at the time your party is scheduled to start.
- Participants cannot enter the water until a certified lifeguard is on duty.
- Non swimmers and children five (5) years of age and under must be accompanied by an adult in the water at all times.
- Flotation devices are not allowed unless distributed by COM Aquatics Inc. management.
- All swimmers must wear swimsuits/gear specifically designed for use in the water. No cut-offs.
- Lifeguards can take pool privileges away from a misbehaving child.
- **NO GLASS CONTAINERS ALLOWED IN THE FACILITY.** Water in plastic containers is acceptable. No colored beverages or confetti are allowed.
- All equipment must be picked up and put back in its appropriate place.

ROPE SWING:

- The rope swing will only be used at times designated by the life guard
 - Only one person allowed on the rope at a time.
 - Only swing from the rope if a lifeguard is present.
- Swing from the rope and immediately return to the side of the pool and exit.

Any serious violation of these rules will result in an immediate end to the party and NO REFUND or any fees.
